



## LEA Plan for Safe Return to In-Person Instruction and Continuity of Service Pursuant to the Federal American Rescue Plan Act, Section 2001(i)

### Introduction and Background

As announced in the New Jersey Department of Education (NJDOE)'s [April 28, 2021 broadcast](#), in March 2021 President Biden signed the Federal [American Rescue Plan \(ARP\) Act](#), Public Law 117-2, into law. The ARP Act provides an additional \$122 billion in Elementary and Secondary School Emergency Relief (ARP ESSER) to States and school districts to help safely reopen, sustain the safe operation of schools, and address the impacts of the COVID-19 pandemic on the nation's students. As with the previous ESSER funds available under the Coronavirus Aid, Relief and Economic Security (CARES) Act, and the Coronavirus Response and Relief Supplemental Appropriations Act (CRRSA), the purpose of the additional funding is to support local educational agencies (LEAs) in preparing for and responding to the impacts of COVID-19 on educators, students, and families. Section 2001(i)(1) of the ARP Act requires each LEA that receives ARP ESSER funds to develop and make publicly available on the LEA's website, no later than 30 days after receiving ARP ESSER funds, a plan for the safe return to in-person instruction and continuity of services for all schools (Safe Return Plan). A Safe Return Plan is required of all fund recipients, including those that have already returned to in-person instruction. Section 2001(i)(2) of the ARP Act further requires that the LEA seek public comment on the Safe Return Plan and take those comments into account in finalization of the Safe Return Plan. Under the interim final requirements published in [Volume 86, No. 76 of the Federal Register](#) by the U.S. Department of Education (USDE), an LEA must periodically, but no less frequently than every six months through September 30, 2023, review and, as appropriate, revise its Safe Return Plan.

Pursuant to those requirements, **LEAs must submit to the NJDOE and post on their website their Safe Return Plans by June 24, 2021.** The NJDOE intends to make LEA ARP ESSER Fund applications available in EWEG on May 24, 2021 and LEAs will submit their Safe Return Plans to the NJDOE via EWEG. To assist LEAs with the development of their Safe Return Plans, the NJDOE is providing the following template.

This template incorporates the federally-required components of the Safe Return Plan. The questions in the template below will be included in the LEA ARP ESSER Fund application in EWEG. LEAs will submit responses to the questions within the LEA ARP ESSER Fund application in EWEG by June 24, 2021. The NJDOE hopes that this template will allow LEAs to effectively plan for that submission and to easily post the information to their websites as required by the ARP Act.

Note that on May 17, 2021, Governor Murphy [announced](#) that upon the conclusion of the 2020-2021 school year, portions of Executive Order 175 allowing remote learning will be rescinded, meaning that schools will be required to provide full-day, in-person instruction, as they were prior to the COVID-19 Public Health Emergency. The NJDOE and New Jersey Department of Health will share additional information regarding State requirements or guidance for health and safety protocols for the 2021-2022 school year as it becomes available.

## 1. Maintaining Health and Safety

### A. Universal and correct wearing of masks

Wildwood Public Schools will adhere to current and relevant CDC guidance regarding universal and correct mask wearing as well as relevant and current Executive Orders issued by the State of New Jersey. Students that attend Wildwood Public Schools will be required to wear masks throughout the facility during the school day or until different guidance is issued regarding universal and correct mask wearing by the CDC and/or New Jersey Department of Health. Wildwood Public Schools Policy 1648 and 5511 reflect the District's masking expectations and requirements. In addition to signage around the building, email and social media reminders will be distributed to students, parents, and guardians regarding universal and correct wearing of masks.

### B. Physical distancing (e.g., including use of cohorts/podding)

Wildwood Public Schools will adhere to current and relevant CDC guidance regarding physical distancing as well as relevant and current Executive Orders issued by the State of New Jersey. Students that attend Wildwood Public Schools will be expected to physically distance throughout the facility during the school day or until different guidance is issued regarding physical distancing by the CDC and/or New Jersey Department of Health. Students will remain three (3) feet socially distanced in the classrooms and common areas wearing masks. In addition, signage regarding social distancing is displayed throughout the district. Email and social media reminders will be distributed to students, parents, and guardians regarding physical distancing expectations.

### C. Handwashing and respiratory etiquette

Wildwood Public Schools will adhere to current and relevant CDC guidance regarding handwashing and respiratory etiquette as well as relevant and current Executive Orders issued by the State of New Jersey. Students that attend Wildwood Public Schools will be expected to utilize the hand sanitizer and disinfecting wipes that are in all classrooms and common areas throughout the facility during the school day or until different guidance is issued regarding handwashing and respiratory etiquette by the CDC and/or New Jersey Department of Health. In addition, signage regarding hand washing and respiratory etiquette are displayed throughout the district. Email and social media reminders will be distributed to students, parents, and guardians regarding the District's handwashing and respiratory etiquette expectations.

### D. Cleaning and maintaining healthy facilities, including improving ventilation.

The Wildwood Public Schools will continue to sanitize, disinfect and clean the facility daily including the District's school buses after the completion of each bus route. Furthermore, disinfecting wipes are available in each classroom for students to disinfect their desks and instructional area before and after use. The District has also increased the amount and frequency of surface disinfecting before, during, and after the student day. The Wildwood Public Schools will continue to monitor and assess HVAC systems as outlined in policy 7421. Wildwood Public Schools policy 1648 reflects the District's cleaning, disinfecting, and ventilation expectations and procedures.

#### **E. Contact tracing in combination with isolation and quarantine, in collaboration with the State, local, territorial, or Tribal health departments**

The Wildwood Public Schools will continue to utilize isolation rooms for unvaccinated students that are in attendance and presenting symptoms of COVID-19 at school. Furthermore, unvaccinated students suspected of having COVID-19 will be directed to get tested for COVID-19 and self-quarantine based on current and relevant CDC and/or New Jersey Department of Health guidance. The District will continue to work in partnership and communicate with the Cape May County Department of Health regarding self-quarantine periods for identified students, faculty, and staff. Wildwood Public Schools policy 1648 outlines the District's contact tracing and isolation procedures.

#### **F. Diagnostic and screening testing**

The Wildwood Public Schools will continue to utilize the self-screening tool that was provided by the NJDOH that reflects COVID-19 screening requirements for unvaccinated students, faculty, and staff. The screening requirements are delineated in Wildwood Public Schools policy 1648. Furthermore, unvaccinated students, faculty, and staff that manifest or present symptoms of COVID-19, based on the screening tool, will be directed and expected to follow the most current and relevant guidance regarding self-quarantine provided by the CDC and/or the New Jersey Department of Health. The District's COVID-19 screening tool will be distributed to students, faculty, and staff at the beginning of the school year. In addition, weekly reminders and social media posts will be shared with stakeholders to re-enforce the District's self-screening expectations for unvaccinated individuals. Faculty and staff will continue to monitor students for any signs of illness and report any concerns to the school nurses.

The Wildwood Public Schools is participating in the State-sponsored COVID-19 testing program for unvaccinated faculty and staff. In addition, students and their families were sent information regarding opting-in to participate in the State-sponsored COVID-19 testing program.

#### **G. Efforts to provide vaccinations to educators, other staff, and students, if eligible.**

Since vaccinations were made available to educators and staff working in educational settings, the Wildwood Public Schools has and continues to provide coverage for faculty and staff during their vaccination appointments regardless of when the appointment was scheduled. To date more than 90% of the district faculty and staff have been fully vaccinated. In addition, the District partnered with Walgreen's Pharmacy and the City of Wildwood to provide vaccinations to eligible students in May 2021 through local vaccination clinics. The District has also emailed and posted to social media vaccination locations for students, faculty, staff, and community members to get vaccinated. These locations included Walgreens and Complete Care.

#### **H. Appropriate accommodations for children with disabilities with respect to the health and safety policies**

Wildwood Public Schools will continue to accommodate students with disabilities with respect to health and safety policies. These accommodations will be in consultation with the IEP team, the student's healthcare provider, the school nurses, and the District's physician of record. Accommodations will also be made for students that have a 504 plan.

## 2. Ensuring Continuity of Services

The Wildwood Public Schools will continue to utilize assessment data, including data from the new State mandated "Start Strong" assessments in Fall 2021, to determine the educational needs of students and the interventions necessary to accelerate learning. The District will provide remediation and enrichment activities, including summer school for current students. Returning students will also have access to 1:1 technology for access to academic and mental health opportunities. The school counseling office will hold orientations for incoming student. In addition, the district's CORE Team, including the CST Supervisor, Nurses, SAC, Guidance Counselors, Psychologist and Social Worker will continue to counsel and work with students to maintain continuity of services.

The Wildwood Public Schools sought public comment on this plan by sending notice, and soliciting comments to all stakeholders in the District's database, along with instructions for how to provide comments via email. The plan has also been posted to the District's website.
